Mr. Land gave his feedback about each bid proposal. Ms. King made a motion for bid #3 and Ms. Gibson seconded the motion to hire Advanced Installation to do the concrete work for \$8,400 and the motion passed.

The board has requested that the management company order the iPad for the community and they will have at least three individuals run the program for the monument sign.

New Business

Under new business, Ms. King discussed the property walk she took with Ms. Dukes and Texans Landscaping Rivera to improve the landscaping for the community. Mr. May made a motion to accept Texans Landscaping Rivera's proposal and Ms. Dukes seconded the motion and the motion passed.
